



Patient-Reported Outcomes (PRO) Infrastructure Workshop Overview and Agenda

The Patient-Centered Outcomes Research Institute (PCORI) is an independent, non-profit research organization created by the Patient Protection and Affordable Care Act of 2010. The mission of PCORI is to help people make informed health care decisions – and improve health care delivery and outcomes – by producing and promoting high-integrity, evidence-based information – that comes from research guided by patients, caregivers and the broader health care community. Research commissioned by PCORI aims to be responsive to the values and interests of patients and provide patients and those who care for them with reliable, evidence-based information for the health care choices they face.

PCORI along with the PCORI Methodology Committee will host a Patient-Reported Outcomes (PRO) Infrastructure Workshop to discuss strategies for increasing the use of PROs in electronic health records (EHRs) on November 19-20, in Atlanta, Georgia. The workshop is focused on developing an action plan for enhancing use of PROs for clinical care, research, and quality performance evaluation. Among the in-person attendees at the workshop are patients, clinicians, researchers, healthcare system leaders, and policy makers. The meeting is publically available via webcast as well.

This workshop goals are the following:

1. Understand **current best practices** for the incorporation of PROs into electronic health records (EHRs)
2. Understand specific **barriers** to the use of patient-reported data, from different stakeholder perspectives, and identify **facilitators** of use of PROs in EHR.
3. Determine **strategies for increasing awareness** of the value of PROs for clinical care, quality performance monitoring, and research use.
4. Create **action items for PCORI and other organizations** for increasing use of PROs in EHRs.

To ensure an interactive meeting, this workshop will include panel sessions with three breakout groups between panel sessions to foster group discussion and to begin to formulate the action agenda for the field.
