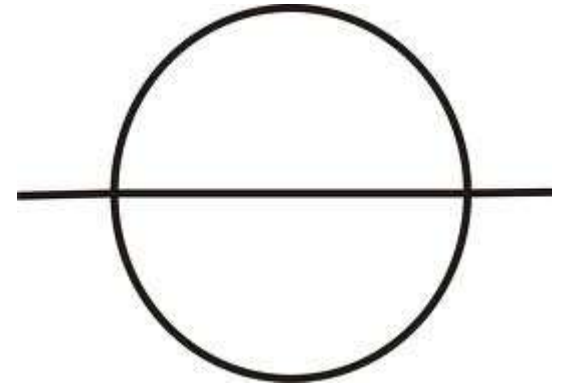

A defining principle of PCOR is ensuring that the patient's voice and perspective drive every step of the research process, including **prioritizing** the **research questions, designing** and **conducting** the research, and **implementing** the results in practice.

The PCOR process – linear or iterative?

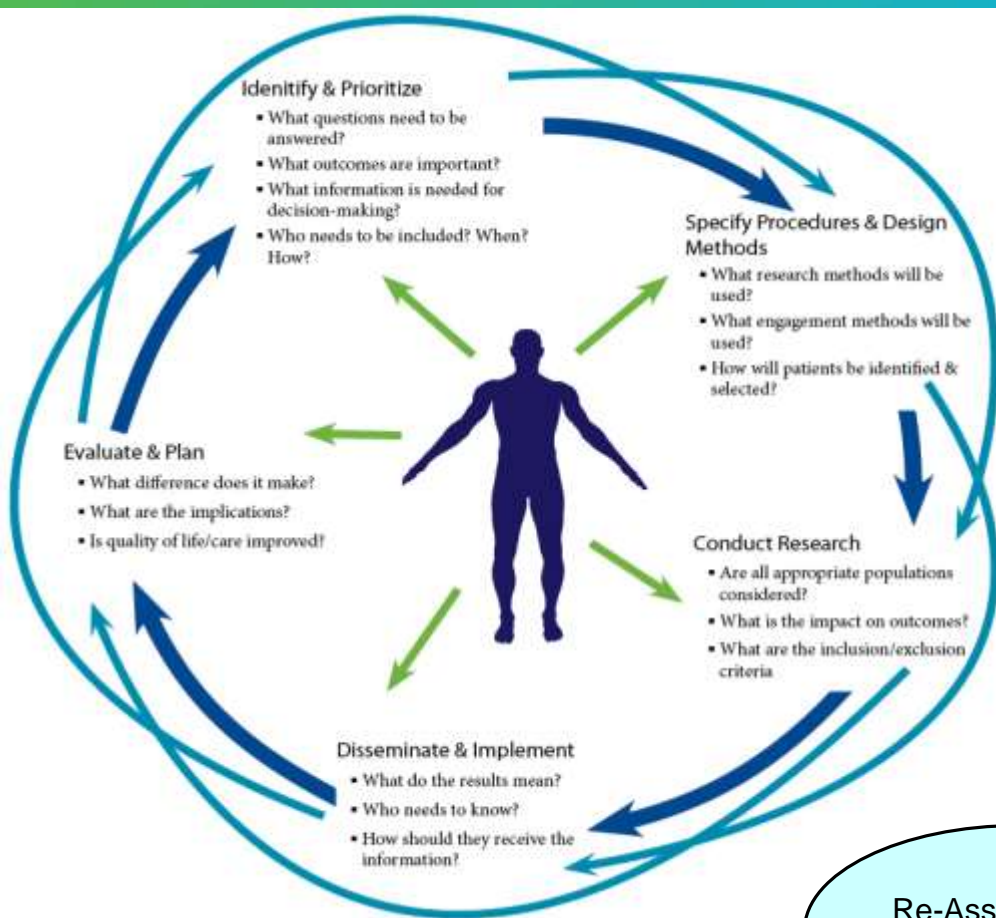


1. selecting research questions

4. designing the study
5. recruiting participants
6. disseminating results
7. implementing findings



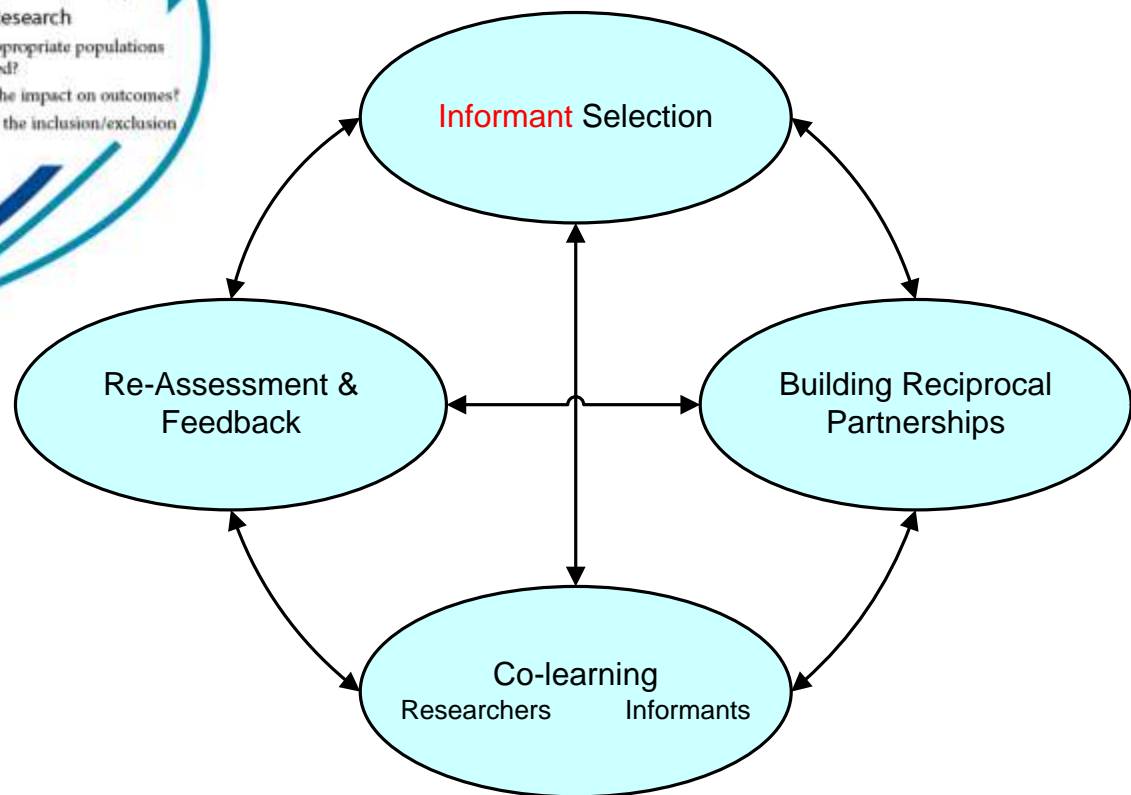

- Discuss PCOR as culture change. How does the work completed by these groups inform us about opportunities to shift the research culture toward patient-centeredness?
 - Discuss specific ways in which patients can be engaged. Discuss specific ways in which clinicians and health systems can be engaged.
 - Consider incentives and disincentives for participation by stakeholder. What do the research team findings discussed here suggest for changing system incentives to enhance PCOR?
- Discuss variability within each stakeholder group of interest. Does the variability along multiple dimensions within the clinical research community matter for implementing PCOR? How should variability of “patients” be addressed?

- What can we learn about implementing standards from the work so far? What do the findings discussed during this workshop suggest about communication strategies for the proposed standards? Who are the target audiences?
- Do any of the findings address differences between patient activism and patient advocacy? Is this distinction a helpful one to make in PCOR?
- Summarize findings related to the role of caregivers in PCOR. From the idea of culture change discussed earlier, what is applicable to caregivers? Do the proposed standards adequately address the role of caregivers or proxies in PCOR?
