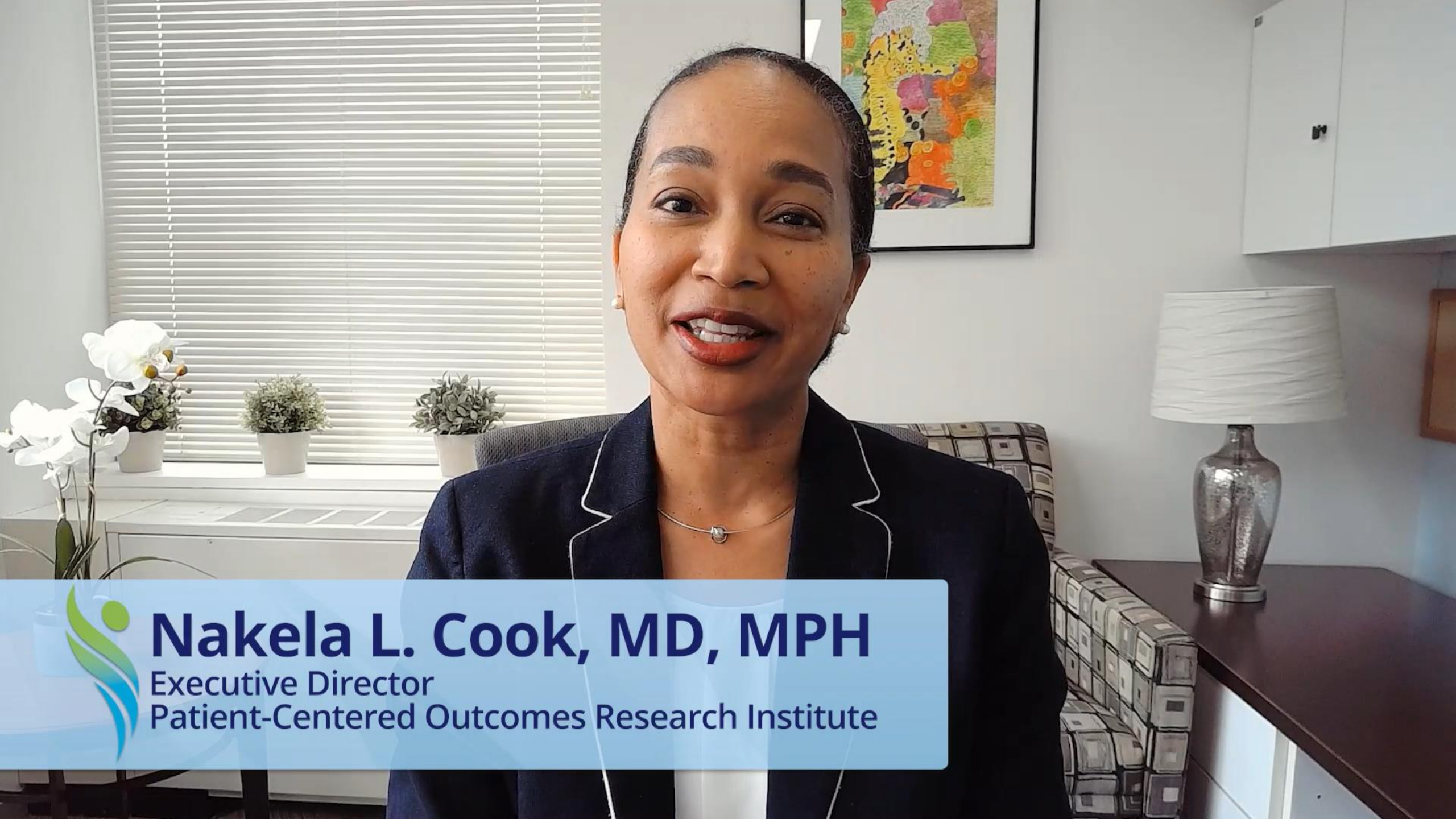

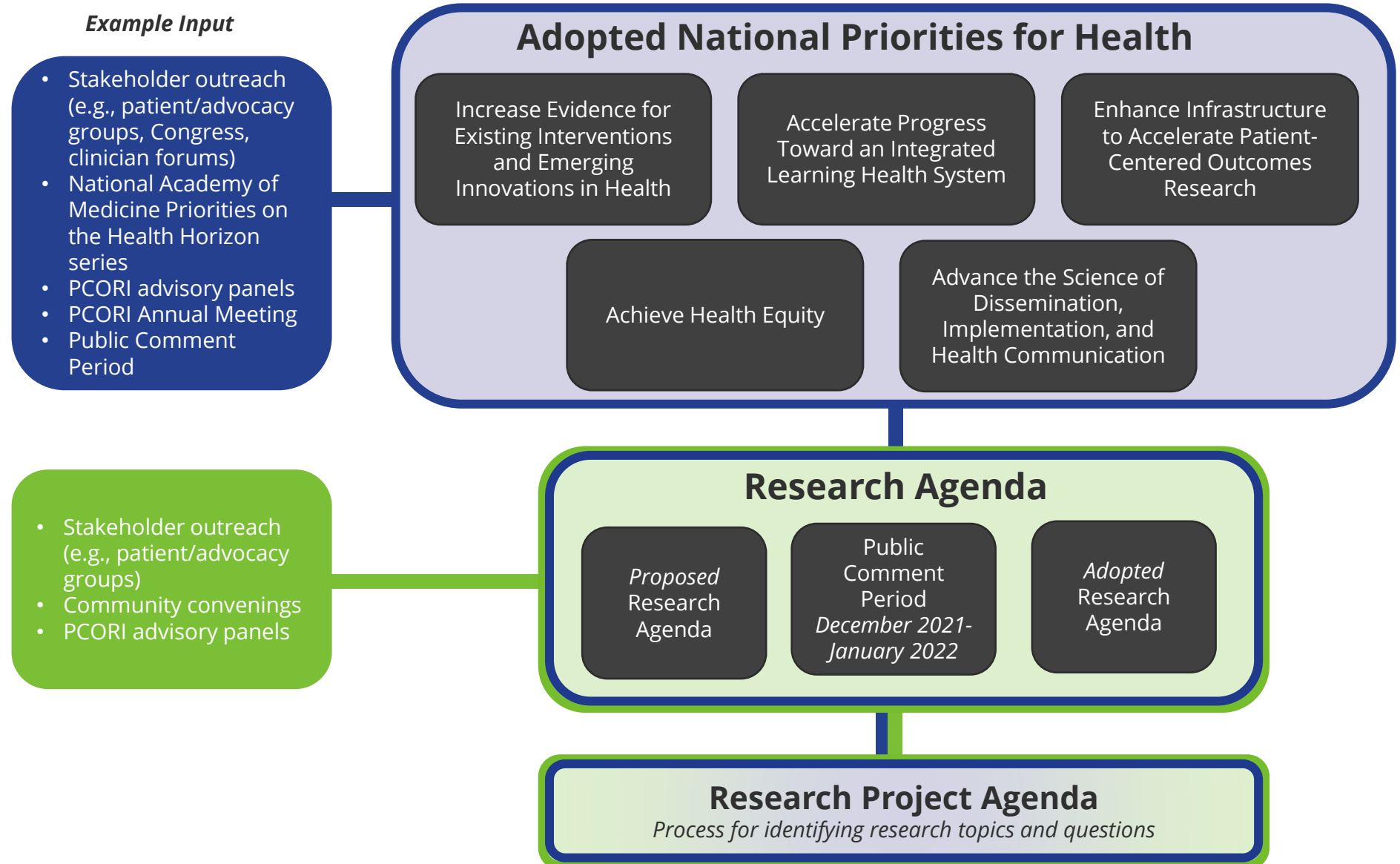

# Adopted National Priorities for Health



## Increase Evidence for Existing Interventions and Emerging Innovations in Health

**Goal:** Strengthen and expand ongoing comparative clinical effectiveness research focused on both existing interventions and emerging innovations to improve healthcare practice, health outcomes, and health equity.



## Enhance Infrastructure to Accelerate Patient-Centered Outcomes Research

**Goal:** Enhance the infrastructure that facilitates patient-centered outcomes research to drive lasting improvements in health and transformation of both the research enterprise and care delivery.



## Advance the Science of Dissemination, Implementation, and Health Communication

**Goal:** Advance the scientific evidence for and the practice of dissemination, implementation, and health communication to accelerate the effective sharing of comparative clinical effectiveness research results for public understanding and uptake into practice.



## Achieve Health Equity

**Goal:** Expand stakeholder engagement, research, and dissemination approaches that lead to continued progress toward achieving health equity in the United States.



## Accelerate Progress Toward an Integrated Learning Health System

**Goal:** Foster actionable, timely, place-based, and transformative improvements in patient-centered experiences, care provision, and ultimately improved health outcomes through collaborative, multisectoral research to support a health system that understands and serves the needs and preferences of individuals.

- This was integrated with input from other convenings, meetings, and discussions.

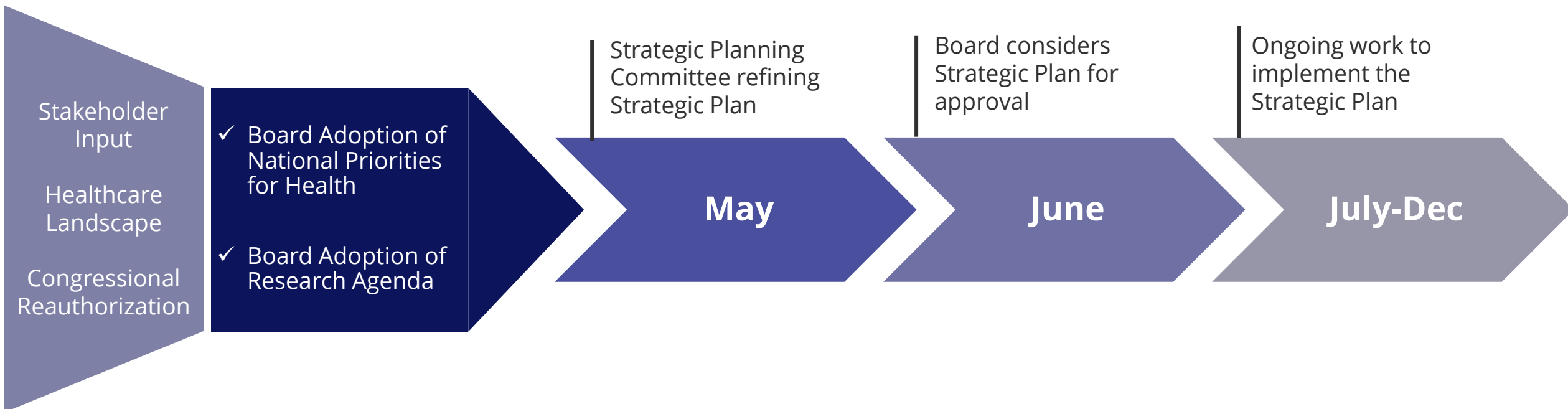
# Adopted Research Agenda

Fund comparative clinical effectiveness research that:

- ▶ Fills patient- and stakeholder-prioritized evidence gaps and is representative and inclusive of diverse and underrepresented patient populations and settings
- ▶ Advances the achievement of health equity and elimination of disparities with an emphasis on overcoming the effects on health and healthcare outcomes of racism, discrimination, and bias
- ▶ Builds the evidence base for emerging interventions by leveraging the full range of data resources and partnerships
- ▶ Examines the diverse burdens and clinical and economic impacts important to patients and other stakeholders
- ▶ Focuses on health promotion and illness prevention by addressing health drivers that occur where people live, work, learn, and play
- ▶ Integrates implementation science and advances approaches for communicating evidence so the public can access, understand, and act on research findings

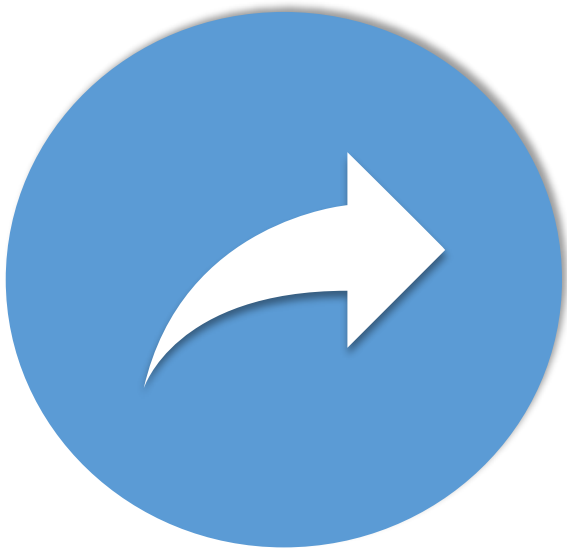
# Moving Towards Implementation Planning

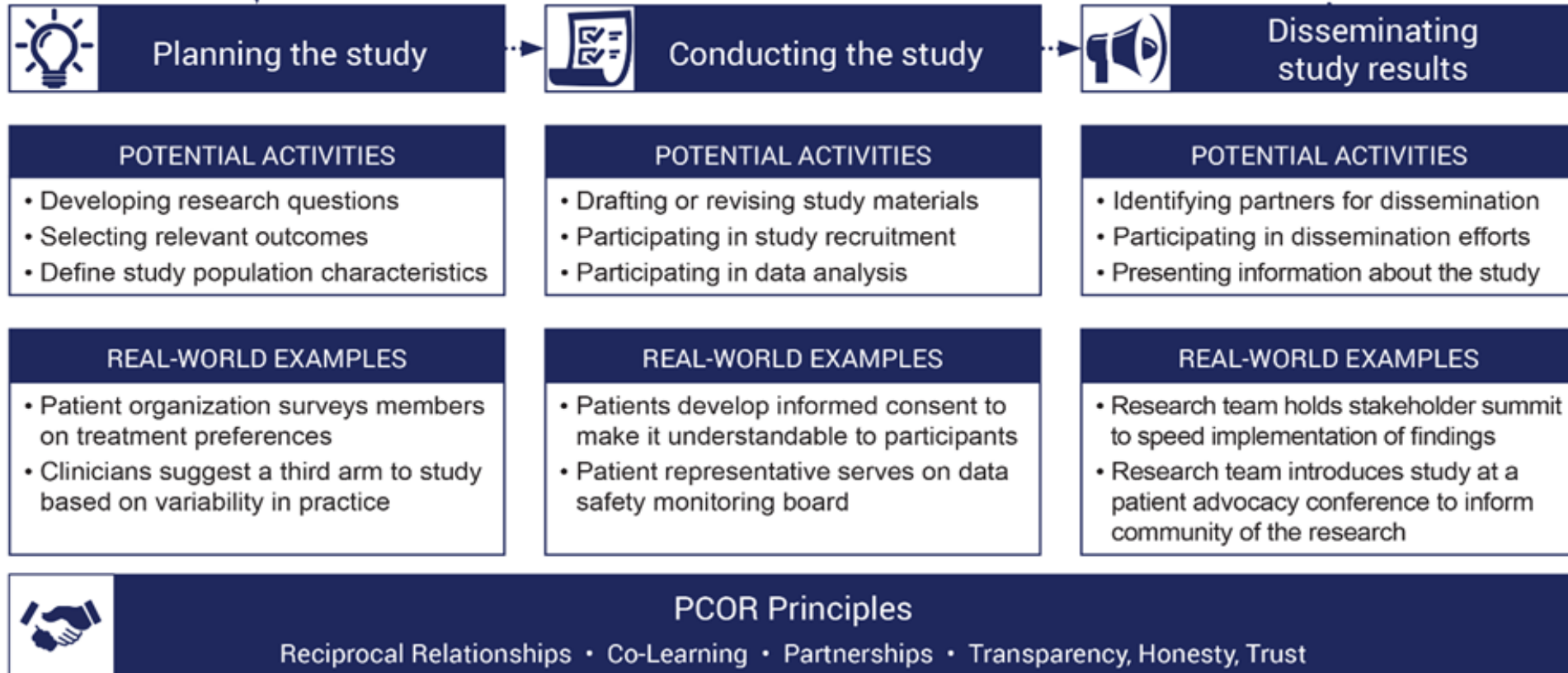

# Engagement Rubric



Reciprocal Relationships: Demonstrated when roles and decision-making authority of all research partners are defined collaboratively and clearly stated  
Co-Learning: Researchers help patient partners better understand the research process, and researchers will learn about patient-centeredness and patient/stakeholder engagement  
Partnerships: The time and contribution of patient and other stakeholder partnership is valued and demonstrated through compensation, cultural competency, and appropriate accommodations  
Transparency, Honesty, Trust: Major decisions are made inclusively and information is shared readily among all research partners

# Engagement Rubric Update

- The [Engagement Rubric](#) was originally developed in 2014 to provide Awardees with *guidance* on **how** and **when** to engage stakeholder partners.
- The next version of the Engagement Rubric will:
  - Be a **cross-departmental and multi-stakeholder** effort
  - **Use knowledge developed** in the natural laboratory created during PCORI's first ten years
  - **Address facilitators and barriers** to engagement
  - Provide **guidance and tools** to support engagement
  - Reflect PCORI's **key priorities for advancing engagement** – both within PCORI and in the field, including diversity, equity & inclusion

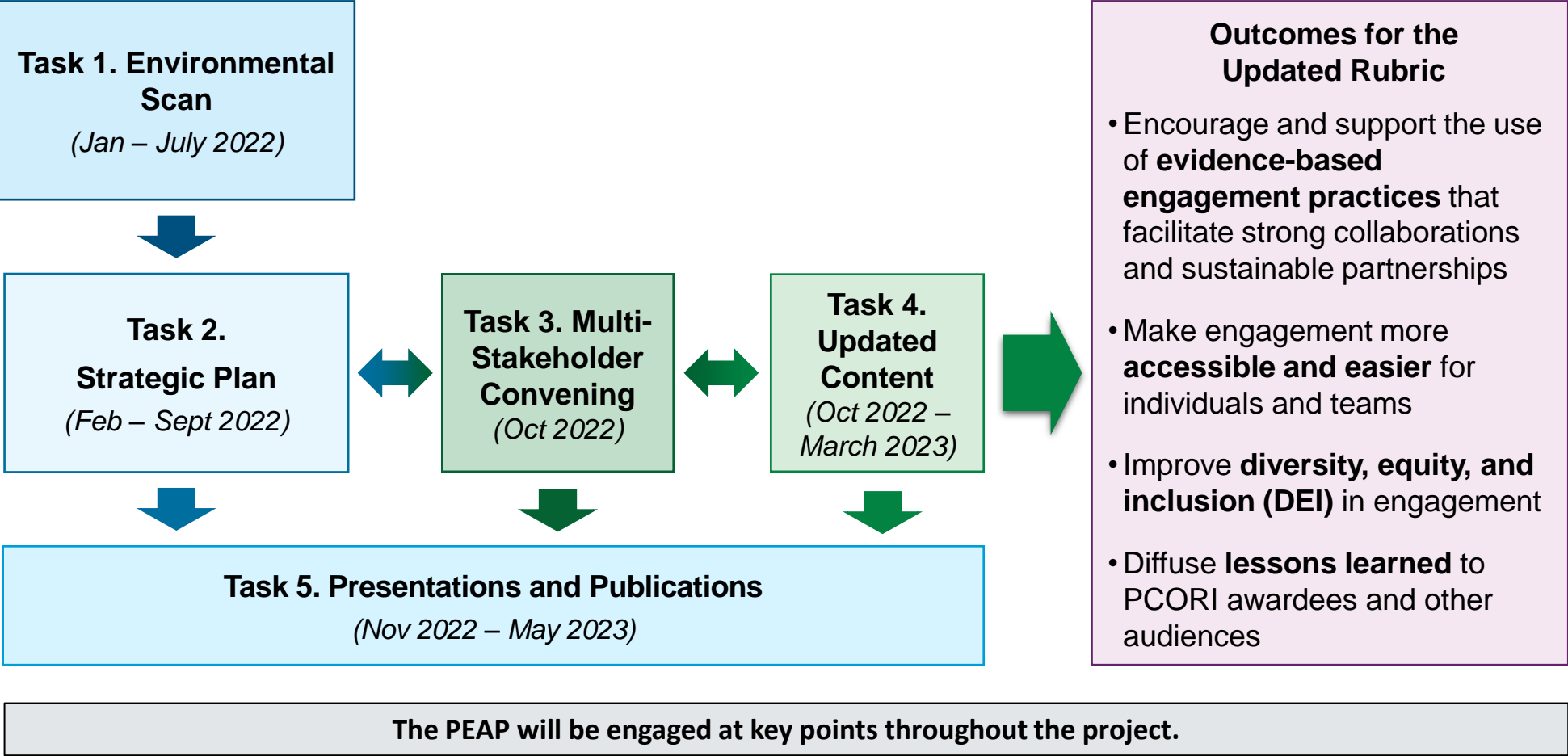
# Project Goal and Objectives

---

- **Goal:** Update the PCORI Engagement Rubric to reflect growing knowledge and experience within the field since 2014 (when the Rubric was first released)
- **What does PCORI want to accomplish with the updated Rubric?**
  - Provide **stronger and practical evidence-based guidance** on how and where PCORI awardees can engage with stakeholders
  - Encourage and support **sustainable and equitable partnerships** between researchers and stakeholders
  - Model a **collaborative and stakeholder-driven process** to update the Rubric
  - Demonstrate PCORI's **leadership** in the field of engagement and **commitment** to diversity, equity, and inclusion (DEI)

# Task 1. Environmental Scan

---

**Goal:** To examine engagement policies, requirements, and guidance external to PCORI to understand their relevance to PCORI-funded research and inform the process of updating Rubric.

## Research Questions:

1. What guidance related to engagement is most relevant to PCORI-funded research?
2. How has engagement guidance been implemented, including barriers, facilitators, and lessons learned?
3. What has been the impact of such guidance?
4. What are the gaps related to engagement in research?

## Activities:

- Literature review of external guidance
- Up to 30 key informant interviews (KIs) with engagement and DEI experts
- 4 focus groups with PCORI research and engagement awardee PIs and patient partners

# Preliminary Findings about External Guidance

Most of the guidance comes as **guidelines and recommendations** and emphasizes the need to amplify patient and stakeholder voices throughout the research process. Stakeholders are involved in developing and communicating engagement guidance.

Barriers to Using Guidance	Facilitators to Using Guidance
<ul style="list-style-type: none"><li>• Cost and time burden on stakeholders</li><li>• Limited funding</li><li>• Limited knowledge of and/or practice in engagement by researchers</li><li>• No requirement or incentive for researchers to engage</li></ul>	<ul style="list-style-type: none"><li>• Monetary and practical support for patients and stakeholders</li><li>• Building trust through respect and transparency</li><li>• Training researchers and stakeholders on how to implement the guidance</li></ul>

# Preliminary Findings about Gaps or Needs the Updated Rubric Could Address

---

1. Provide information about the **minimum time and resources** it takes to “do” engagement with options at each phase
2. Provide **just-in-time resources** for stakeholders and patient partners
3. “Champion” **equity** in engagement
4. Communicate the **value of engagement in research**
5. Need resources and guidance to effectively engage with **diverse stakeholders**

# About the Strategic Plan

---

- **Purpose:** Facilitate strategic discussions to determine how to build on the current PCORI Engagement Rubric using:
  - Guidance identified in the environmental scan report
  - A synthesis of PCORI's research and resources on engagement
  - PCORI staff's practice-based experience with engagement in research
- **Outcome:** A strategic plan that aligns with PCORI's goals, mission, standards and values and will be used to guide the convening and content development

# Key Questions

---

The strategic planning process is intended to answer these questions:

1. Who are the **intended audiences**—both internal and external to PCORI—of the updated Rubric content?
2. How should the updated Rubric content be conceptualized and expanded to **meet current and future needs** and advance the science of engagement?
3. How **prescriptive** should the updated Rubric content be to successfully communicate PCORI's expectations for engagement and help PCORI awardees meet these expectations?
4. What **formats** should be used to present the updated Rubric to meet the needs of different audiences?

# Assessment of Current Rubric (by PCORI staff)

Strengths	Limitations
Is simple, clear, easy to understand and follow, and accessible	Too simple; does not account for nuances of engagement, such as study type, award type, and various types of stakeholders
Makes the process of engagement clear, especially for new PIs	Focuses more on transactions between researchers and stakeholders rather than relationships that happen over time
Provides a framework or map for engagement with “guardrails”	Does not provide specific guidance on what research teams should do to practice meaningful engagement (which leads to variation and can create burden)
Explains PCORI’s engagement principles clearly and concretely with actionable, real-world examples	Assumes researchers have already engaged with and developed relationships with patients and other stakeholders; does not address how to identify and develop relationships with partners (pre-engagement)
Can be used by multiple audiences for multiple purposes (e.g., to influence funders to be more patient-centered)	Does not help users with important actions, such as getting started, applying the information, or addressing specific engagement-related problems
	Is static and does not allow users to filter or interact with it to find the most relevant information (such as an evidence map)
	Does not include enough information related to diversity, equity, and inclusion

# Goals of the Updated Rubric

The goals of the updated Rubric are to: (1) promote and support meaningful and sustainable engagement in CER/PCOR and (2) influence research to be more patient-centered, relevant, and useful

- The updated Rubric will achieve these goals by:
  - **Communicating what PCORI means** by meaningful engagement
  - **Encouraging and inspiring research teams to engage diverse stakeholders** in ways that reflect PCORI values and principles
  - **Supporting bi-directional learning** to continue to build the evidence base for engagement

# Intended Audiences and Potential Uses of the Updated Rubric

Audience	Use
<b>PCORI applicants and awardees</b>	Understand PCORI’s expectations for engaging stakeholders and what success looks like from both the researcher and the stakeholder perspective
<b>PCORI staff</b>	Promote a shared understanding of engagement so that staff can help awardees problem-solve
<b>External audiences</b>	Promote and advance the science of engagement

# Guidance in the Updated Rubric

---

- The updated Rubric should provide information and guidance that addresses what, why, and how including:
  - principles;
  - considerations in addressing those principles; and
  - different options or actions to implement the principles.
- Guidance should be illustrated by real-world examples that address common engagement challenges and represent the diversity of stakeholders engaged and topics that PCORI funds.
- The updated Rubric should also include links to relevant resources.



# Examples of Minimum Expectations

---

- Research teams should use a variety of methods to engage with stakeholders.
- Stakeholder partners should be reflective of the population(s) being studied and impacted by the study, including those who may be “outside” of the healthcare system.
- Research teams should decide together how decisions will be made.
- Research teams should regularly evaluate its engagement plan and activities.
- All team members – researchers and partners – should receive appropriate training to support them in their roles.
- All stakeholder partners should be compensated equitably.

# Overview

## PCORI Approach to Healthcare Cost and Value: Framework for Activities

### Collection of the Full Range of Outcomes

PCORI can ensure the appropriate and relevant data are identified and collected in PCORI awards

Support broadening of PCORI guidance to awardees through literature reviews, patient & stakeholder focus groups to clarify types of potential burdens, costs, and economic impacts to be included in PCORI-funded research, and data sources

Develop guidance for capture of specific types of potential burdens or costs consistent with a patient-centered perspective, as a basis for PCORI guidance to awardees and the field

### Informing the Value Conversation

PCORI can help advance patient-centered approaches to the value conversation by supporting understanding of stakeholder perspectives on what constitutes “patient-centered value”

Conduct a landscape review of current stakeholder statements, perspectives, and frameworks around value

Convene patient and stakeholder groups to identify the components or attributes necessary in “patient-centered value”

### Supporting Policy Priorities

PCORI can consider undertaking specific activities that contribute to priority policy goals (i.e., generating evidence to inform healthcare value discussions)

Consider placing an emphasis on research focused on emerging technologies/therapies

Consider building upon evidence synthesis capabilities to provide more timely information

## Key Questions to Be Answered

- What defines successful engagement, and for whom?
- How can engagement be measured? What indicates that a study is patient-centered?
- What are the approaches that support and achieve successful engagement, particularly for underrepresented populations?
- Under which conditions do approaches work best, and how should they be modified and resourced for different contexts, settings, and communities?
- Which approaches should be combined to achieve engagement aims?

## First PFA Priority Areas

**Development and/or validation of measures, including rapid measure development**, to capture structure/context, process, and outcomes related to both engagement and research, from both the stakeholder and investigator perspective.

**Development and/or testing of engagement approaches** to generate evidence on which specific aspects of engagement are most effective, either alone or in combination, and how effectiveness varies by context, particularly for underrepresented populations.

# Pre-Announcement Overview



The new [Engagement Award: Building Capacity for Small Organizations to Engage in PCOR/CER](#) funding opportunity will support two-year projects that enable small organizations and their communities to build capacity and skills to participate in the PCOR/CER process.

# Pre-Announcement Overview



- The projects will leverage each awardee organization's unique perspectives and experiences to **build the knowledge, competencies, and abilities** of the organization and its community to be meaningful partners with researchers throughout all phases of the PCOR/CER process.
- Awardees will be required to participate in a **learning network** throughout the project period. The learning network will provide an opportunity for awardees to receive **technical assistance** on their projects, share expertise and experiences, and offer lessons learned.
- Two-year projects; up to \$250,000 total (direct and indirect).

# Eligibility

## Applicant Organizations



- Must have an average yearly operating budget of \$1.5 million or less over the past two fiscal years.
- Must be tax-exempt under section 501(c)(3) of the Internal Revenue Code or have a fiscal sponsor that is tax-exempt under section 501(c)(3) of the Internal Revenue Code.
- May not have received a total of over \$100,000 through previous awards from the Eugene Washington PCORI Engagement Award Program. Funds received as a subcontractor on an award do not count towards this total.
- Must demonstrate a) current relationships with researchers and/or existing research networks; and b) current relationships with patients and other stakeholders who have a connection to, expertise in, or lived experience with, the topic area.

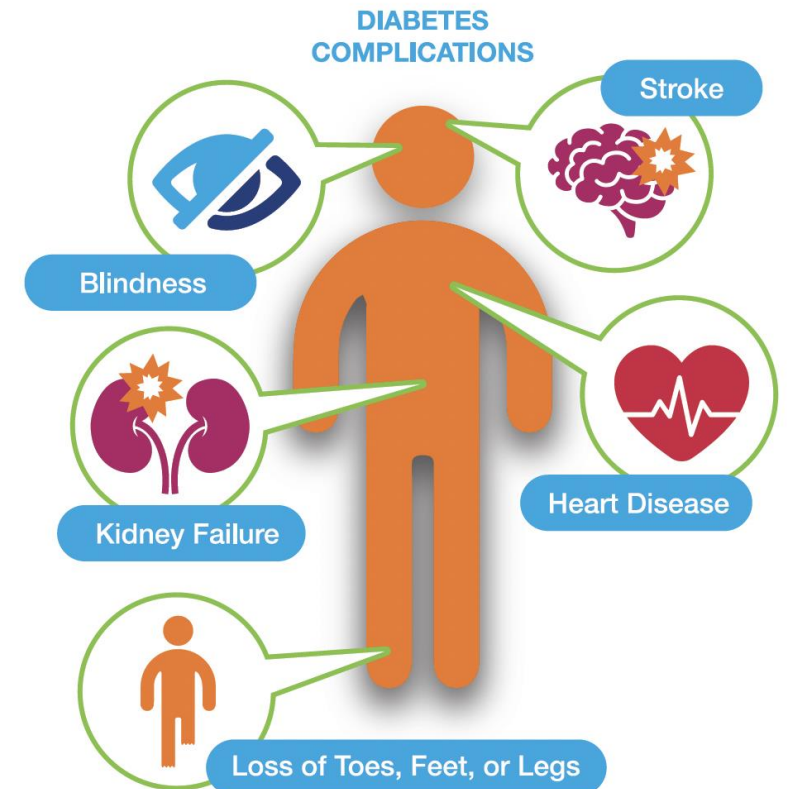

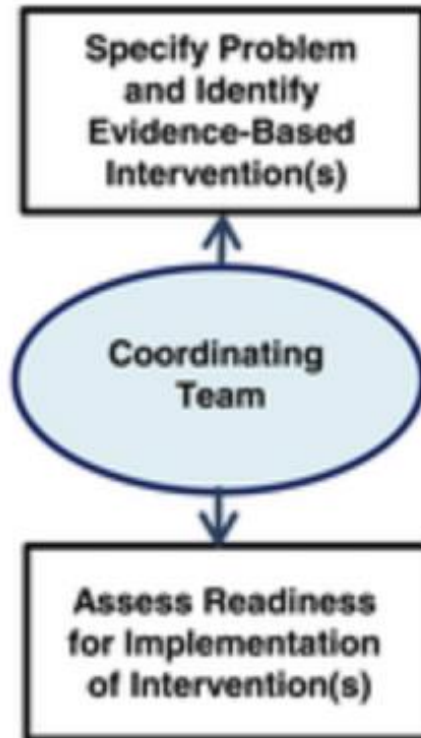

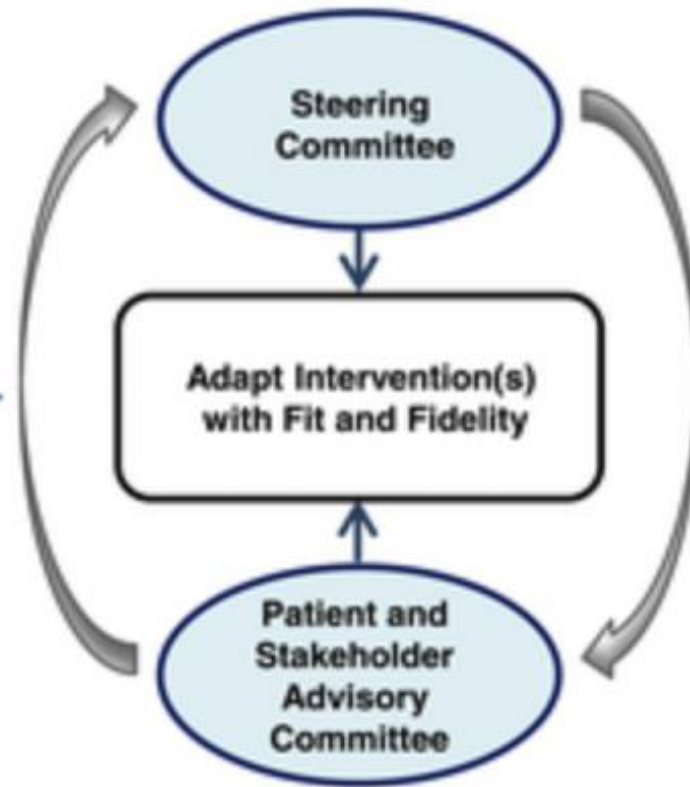

## PASAC

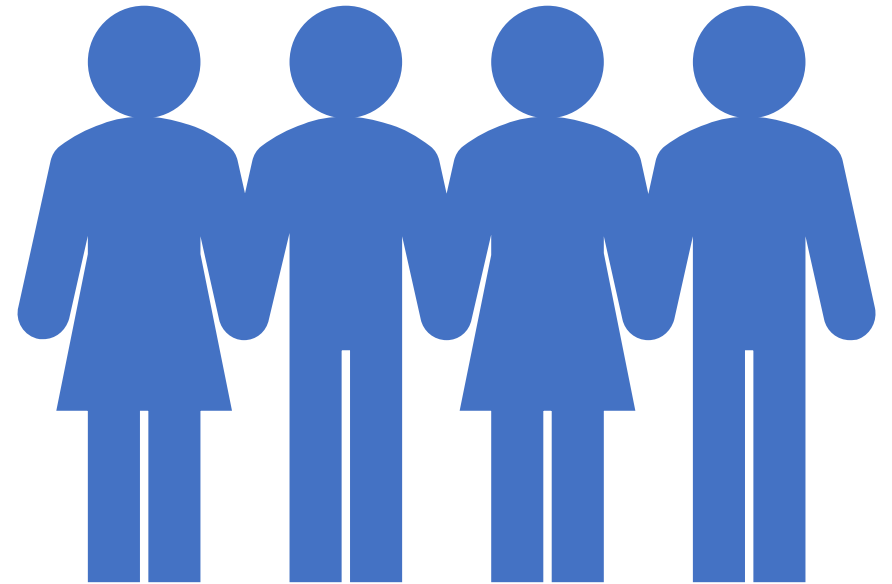
- Co-created prediabetes decision aid
- Participated in development of study plan and inclusion criteria
- Reviewed results and modified decision aid

## Lessons Learned

- Structured agendas
- Draft materials to respond to rather than create
- Between meeting communication
- Balanced composition of the group
- Need for skilled facilitators to balance voices

## Future Opportunities

- Engage participants sooner
- Expand role of participants
- Address patient and community member retention
- Develop novel strategies to sustain engagement between meetings





## Conclusion

- Engaging PASACs informed development, implementation, and dissemination
- Further study is needed to optimize longitudinal engagement and evaluation

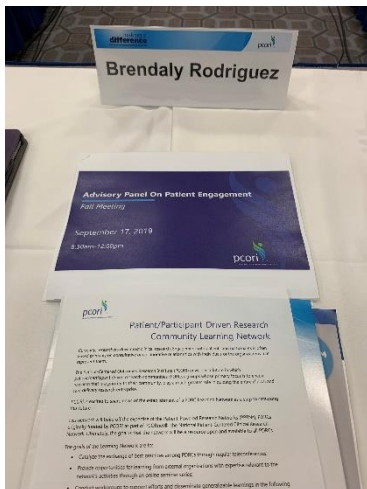
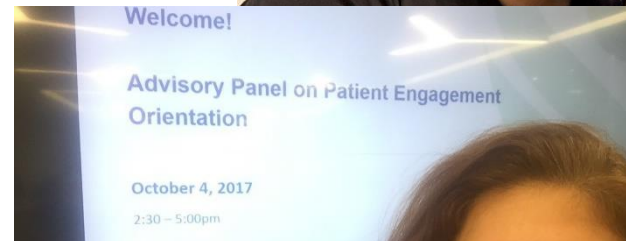
